

**I-195 Redevelopment District
Request for Proposals
For
Interim Concession Space on Lot 5 of Parcels 22 and 25**

Deadline for Submissions: Friday, October 28, 2022 by 3:00PM.

Introduction

The I-195 Redevelopment District (the “District”) is seeking innovative proposals from food operators, private developers, non-profit district management associations or collective teams (the “Proposer”) to design, install, and operate a temporary concession space at I-195 Redevelopment District Lot 5 of Parcel 22 and 25 (location of the Shack/Dune Brothers from 2017-2022), a 9,956 square-foot site in the District. The concession space should include at a minimum one or more eating and/or drinking establishments along with outdoor space that can be used for seating, gatherings and events. This request is an offer by the District to enter into an agreement, in accordance with the terms and conditions of this RFP, for the services proposed by the successful Proposer.

The goal of the temporary concession space is to activate the District by drawing and engaging residents, employees and visitors from the surrounding area. The District intends to enter into a license agreement for up to a five-year term. The expectation is the successful Proposer will commence operations no later than spring of 2023. While a seasonal proposal is acceptable, the District encourages proposals that will operate year round and in all cases encourages operators to provide regular hours including evenings and weekends.

The District will require the successful Proposer to perform all work related to the installation, operation and removal of the concession. There will be no financial assistance available to subsidize installation or operation of the space.




Figure 1. Lot 5 District within I-195 Redevelopment


About the District

The District and its governing Commission were created in late 2011 to serve as the responsible authority for the sale, marketing, and oversight of land made available in downtown Providence as a result of the relocation of Interstate 195. The I-195 Redevelopment Act of 2011 designates the District parcels for “commercial, institutional and residential development and beneficial reuse, including without limitation to support or encourage workforce development, education and training, and the growth of ‘knowledge-based’ jobs and industries such as research and development, life sciences, media technologies, entrepreneurship and business management, design, hospitality, software design and application, and a variety of other uses consistent with a “Knowledge-based economy.”

The Commission’s mission is to foster economic development on Rhode Island's 195 land and beyond and generate job creation opportunities that embrace the city's demographics by creating an environment that encourages high-value users to build well-designed structures that enhance the value of surrounding neighborhoods and augment the sense of place.

Background




Figure 2. Parcels 22 and 25 Final Subdivision Plan

The District encompasses 26 acres in the heart of Providence, Rhode Island (see Figure 2). Located on land formerly occupied by Interstate 195, the District spans the east and west sides of the Providence River and crosses through several Providence neighborhoods including Downtown, the Jewelry District, College Hill, and Fox Point.

Significant public investments in the area include:

- The award-winning Michael S. Van Leesten Memorial Bridge across the Providence River
- The Providence Innovation District Park, a riverfront park comprised of nearly seven acres of new open space
- City Walk – part of a citywide urban trail network that runs through the District and creates regional connections between Providence neighborhoods, parks, and civic institutions
- The Downtown Transit Connector (DTC) – a high frequency, direct bus rapid transit service from the Providence Amtrak/MBTA Station and Hospital District, routed through the District
- An approximately 1,300-car publicly accessible garage sited adjacent to the District

The first private development in the District, Point225, opened in August 2019. The 200,000-SF commercial building is anchored by the Cambridge Innovation Center, Johnson & Johnson, and Brown University’s School of Professional Studies. Chestnut Commons, a 92-unit multifamily residential project located on Parcel 30, opened in 2020, Aloft Hotel opened in November of 2021, and Emblem 125, a 248-unit multifamily development with ground-floor retail opening in 2022, located on Parcel 28 opened in 2022. Currently, one project is under construction: Parcel 6, a mixed-use development with 62 units of mixed-income housing, ground-floor retail, and a Trader Joe’s. Several additional projects are in predevelopment.

Providence Innovation District Park opened in 2019 and is owned and operated by the District. The park is heavily programmed with approximately seventy events on the calendar this season, and two seasonal, semi-permanent food and beverage establishments that include a beer garden with a food truck program and an ice cream vendor. Approximately five thousand people visit the park each day with over approximately 400,000 total visits this summer.

Existing Conditions

Structure and Improvements

The District envisions the installation of a temporary (non-mobile) structure. Proposers may consider the use of various existing modular and/or prefabricated building systems for the site improvements. The trailer currently located onsite is not included with the award of this RFP and is temporarily located there until a selection is made.




Figure 3. Existing Conditions 1

The current site improvements (landscaping, hardscaping, fencing, etc.) will remain, although Proposers can remove or modify the existing improvements. Any proposed alterations should be clearly articulated in the response.

Utilities

The site has electricity service; however, water is accessed through the adjacent building located at the One Ship Street, and there is no sewage hook-up. The District will consider proposals to add permanent water service at the cost of the operator.

Permitting

The successful Proposer will be responsible for all necessary permits and licensure necessary to operate. In addition to providing the District with copies.

SUBMISSION REQUIREMENTS

Cover Letter

A cover letter with the original signature of the person having proper authority to make the proposal should be provided, which should include:

- the Proposer
- the date the Proposer was established
- the name and address of the all entities involved in the operations and programing,
- the name, address, email, and telephone number of the person or persons who will serve as the principal contact with the District staff and be authorized to make representations on behalf of the entity.

Narrative and Description

Proposers shall provide the following information:

- 1) Description of Proposer's vision for the project, including plans for any updates to the design and any anticipated new construction in the space.
- 2) Operations plan including, but not be limited to, hours of operation, staffing, maintenance including a plan for trash, loading and unloading schedules, and public space description and activities. Please clearly state how the utility limitations noted above are incorporated into the plan.
- 3) Statement of Qualifications including existing and recent food/beverage/retail operations; development/building and placemaking experience, including specific locations, types of businesses, number of years in business; information on customer base and/or sales, etc.

- 4) Monthly and annual expense and revenue projections including proposal for monthly license fee payable to the District.
- 5) Implementation schedule, including construction schedule (if applicable), schedule for obtaining any necessary permits, and anticipated opening date. Schedule for removal of the structure and clearance of the site at the end of the lease term.
- 6) Three (3) references for the principal(s) representing business relationships, e.g., vendor, banking, etc. Provide the name of the organization, services, contact name, telephone number, and email.

The District and its staff reserve the right to request further information from finalists.

Administrative Proposal Elements

- Acknowledgement of the Conflict-of-Interest Affidavit requirements (see Appendix A).
- Certification that a Certificate of Good Standing from the Rhode Island Division of Taxation will be delivered to the District upon award.
- A listing of all current and on-going contracts which may be of conflict of interest.
- A disclosure of all outstanding financial obligations with the State of Rhode Island.
- Completion of the ISBE participation plan form attached as part of Appendix B.

The District will not provide any reimbursement for any cost associated with the development or presentation of a proposal.

ISBE Participation

The Rhode Island Department of Administration has defined an ISBE as a small business enterprise that is owned by one or more individuals who are women or minorities as defined by R.I. Gen. Laws § 34-17.1-3 that is owned or controlled by one or more individuals with disabilities as defined by R.I. Gen. Laws § 37-2.2.-2. To be recognized, the business must be certified as either:

1. A minority business enterprise by the Office of Diversity, Equity, and Opportunity, a division in the Department of Administration (“ODEO”);
2. A women business enterprise by ODEO; or
3. A Disability Business Enterprise by the Governor’s District on Disabilities.

The District supports the fullest possible participation of ISBEs in the procurement of services.

A. Proposer's ISBE Responsibilities (from 150-RICR-90-10-1.7. E)

1. Proposal of ISBE Participation Rate. The Proposer shall be responsible for completing and submitting all standard forms adopted pursuant to 105-RICR-90-10-1.9 and submitting all substantiating documentation as reasonably requested by either the Using Agency's MBE/WBE Coordinator, Division, ODEO, or Governor's District on Disabilities including but not limited to the names and contact information of all proposed subcontractors and the dollar amounts that correspond with each proposed subcontract.
2. Failure to Submit ISBE Participation Rate. Any Proposer that fails to submit a proposed ISBE Participation Rate or any requested substantiating documentation in a timely manner shall receive zero (0) ISBE participation points.
3. Execution of Proposed ISBE Participation Rate. Proposers shall be evaluated and scored based on the amounts and rates submitted in their proposals. If awarded the contract, Proposers shall be required to achieve their proposed ISBE Participation Rates. During the life of the contract, the Proposer shall be responsible for submitting all substantiating documentation as reasonably requested by the Using Agency's MBE/WBE Coordinator, Division, ODEO, or Governor's District on Disabilities including but not limited to copies of purchase orders, subcontracts, and cancelled checks.
4. Change Orders. If during the life of the contract, a change order is issued by the Division, the Proposer shall notify the ODEO of the change as soon as reasonably possible. Proposers are required to achieve their proposed ISBE Participation Rates on any change order amounts.
5. Notice of Change to Proposed ISBE Participation Rate. If during the life of the contract, the Proposer becomes aware that it will be unable to achieve its proposed ISBE Participation Rate, it must notify the Division and ODEO as soon as reasonably possible.
