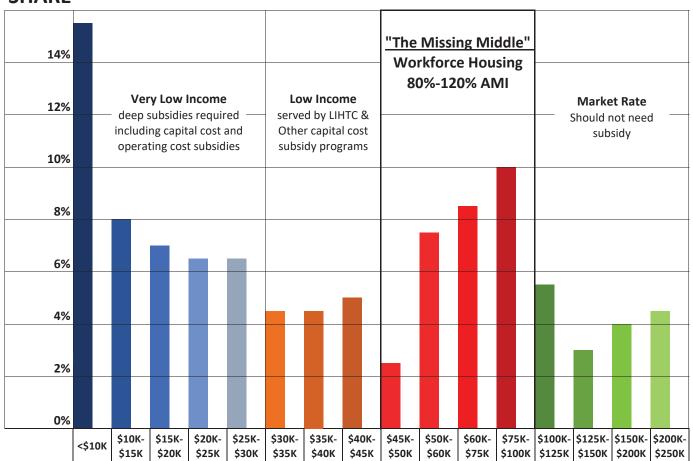

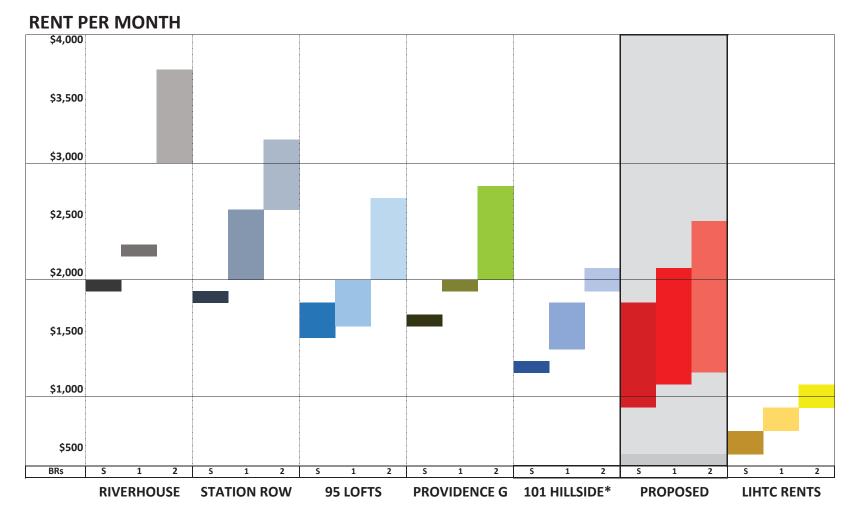

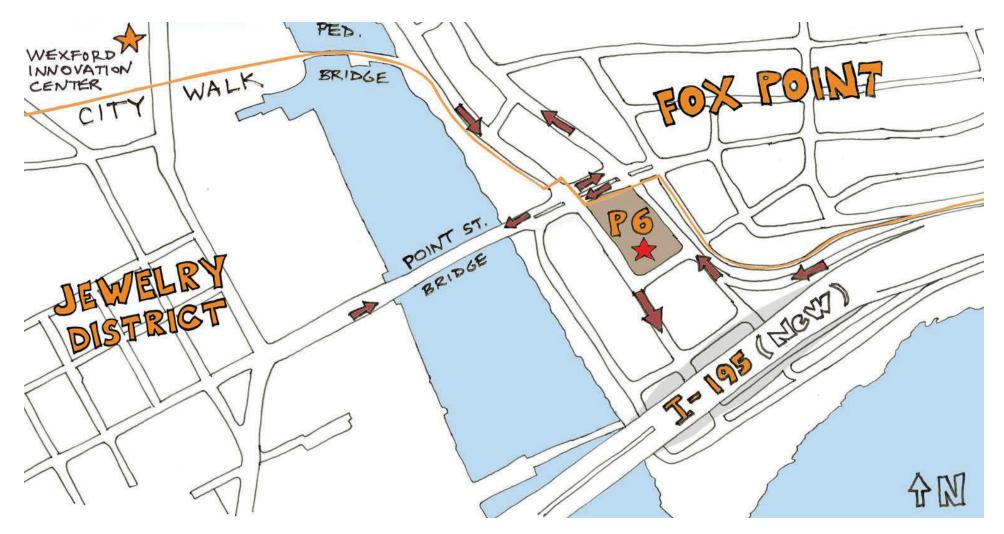
COMPETETIVE MARKET - RENTAL RANGE CHART

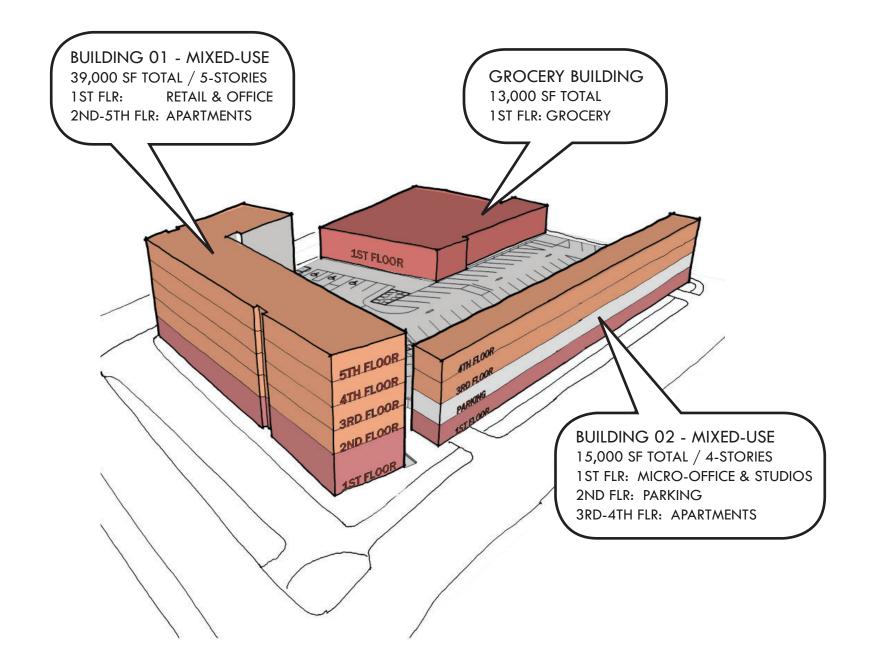
